

2. IV Cannula policy: A cannula should be removed when it's no longer needed for treatment or hasn't been used in 24 hours. It should also be replaced every 72–96 hours to reduce the risk of infection and phlebitis – area of cannula is checked for redness, pain and inflammation and if there is any problem at the site.. it must be removed.
3. As a part of International infection prevention control week (3rd week of October) a workshop is being held at training centre to educate all the nursing staff regarding prevention of infection.
